- **East Side: Holiday Inn**, 780 Beta Dr., Mayfield Village. (Exit I-271 at Wilson Mills)  
Bus arrives at approximately 6:30 a.m. and leaves immediately after loading. Be sure to arrive early.
- **Far East Side:** Best Friends Restaurant, 1741 State Route 534, Geneva (just north of I-90).  
Bus arrives at approximately 7:00 a.m. and leaves immediately after loading. **This stop is by request only. Please tell the trip leader in advance if you want to board here.**
